Turn by turn directions for CAC Christmas Festive Award Town Tour 2025

Start at the Municipal Parking Lot at 51 Shoreline Drive.

Left onto Plantation Drive heading North and then left onto Massachusetts where you will see **1401 Plantation** on your Right and <u>110 Massachusetts</u> (<u>WINNER</u>) and **112 Massachusetts** on your Left. Go to the end of Massachusetts, circle around the cul-desac and travel back to Plantation Drive.

Turn right onto Plantation, then turn right onto Gatewood Drive; continue on Gatewood and turn left onto Parkwood Court and circle around in the cul-de-sac; **103 Parkwood Court** will be on your right.

Turn left on Gatewood Drive and continue past where Gatewood turns right. **286 Gatewood** will be on your left and **293 Gatewood** will be on your right.

Turn right on Pinewood Drive and **204 Pinewood Drive** will be on your right; then turn right onto Virginia Avenue and go all the way to the back and **113 Virginia Avenue** will be at the end of the cul-de-sac. Travel back to Pinewood and turn left.

Turn right onto Gatewood Drive. **310 Gatewood** will be on your left; **345 Gatewood** will be on your right; **401 Gatewood** (WINNER) will be on your right; **420 Gatewood** will be on your left. Go to the end of Gatewood cul-de-sac and travel back to Pinewood Drive.

Turn right onto Pinewood Drive then turn right on Rockledge Road. Now turn left onto Shoreline Drive. **314 Shoreline Drive** will be on your right; continue on Shoreline and **290 Shoreline Drive** and **260 Shoreline Drive** will be on your right; continue around the bend on Shoreline and

231 Shoreline Drive will be on your left.

Continue on Shoreline Drive and turn left onto Randomwood Lane; then turn left onto Willowbrook Court; **307 Willowbrook Court** will be on your left. Turn around in the cul-

de-sac and travel back to Randomwood; turn left and go to the end of Randomwood and turn right onto Rockledge Road.

At the end of Rockledge Road is **99 Shoreline Drive** on your left. Turn right onto Shoreline Drive.

Turn left onto Plantation Drive and **210 Plantation Drive** will be on your right; continue on Plantation Drive and turn right onto Gangplank Road; **202 Gangplank Road** will be on your right and **212 Gangplank Road** will be at the end of the cul-de-sac. Turn around in the cul-de-sac and head back to Plantation Drive.

Turn right onto Nautical Drive and **202 Outrigger Road** will be right in front of you. Turn left onto Outrigger and turn around in the cul-de-sac. Turn right on Nautical Drive and then turn right onto Plantation Drive and you will arrive at **711 Plantation Drive** on your left.

Turn right onto Knotline Road; drive to the end of the cul-de-sac where **109 Knotline Road** is. Circle back to Plantation Drive.

Turn right onto Plantation Drive and then turn right onto Channel Run. **107 Channel Run** will be on your left. Then turn right onto Pilot Place and **103 Pilot Place** will be on your right as you circle around the cul-de-sac.

Turn right onto Channel Run and **212 Channel Run** will be on your right. Continue on Channel Run and turn right onto Raft Road then right on Sextant Court. **105 Sextant Court** will be on your right as you circle around the cul-de-sac. Turn left on Raft Road then right onto Channel Run.

Turn right onto Boatswain Drive and **104 Boatswain Drive** will be on your right. Continue to the end of the cul-de-sac and circle back to Channel Run.

Turn right onto Channel Run and then right again onto Portside Lane. **103 Portside Lane** will be on your left. Continue to the end of the cul-de-sac and head back to Channel Run.

Turn right onto Channel Run and then turn right onto Plantation Drive. Continue on Plantation Drive to Shoreline Drive and turn right.

Turn right onto Pier Point and go right around the loop. **28 Pier Point**, **33 Pier Point**, and **34 Pier Point** will be in the first section of homes on the right side as you circle

around Pier Point followed by a 3 point turn. **41 Pier Point** will be on the back loop of Pier Point on your right. Circle back to the entrance and then turn right on Shoreline Drive.

Turn right onto Pirates Road and then right again onto Norbury Drive and **120 Norbury** will be on your left and **102 Norbury** at the end of street on your left and adjacent to US 17. Turn right onto US 17 and make a U-turn when possible. From US 17 turn right onto Barbara Drive and

310 Barbara Drive will be on your right. Continue on Barbara Drive and left until you get back to US 17 and then turn right and quickly left at the light into River Bend.

From the entrance of River Bend travel down Shoreline Drive and then turn right on Canebrake Lane and right on Canebrake Drive. **146 Canebrake Drive** will be immediately on your right. Go to the end of the cul-de-sac and circle back and take a left on Canebrake Lane

Turn right onto Shoreline Drive and then turn right onto Wildwood Drive and right into the Municipal Building Parking Lot at 51 Shoreline Drive.
