#### APPLICANT ASSURANCES

The applicant hereby assures and certifies that it will comply with the FEMA regulations, policies, guidelines and requirements including OMB's Circulars No. A-95 and A-102, and FMC 74-4, as they relate to the application, acceptance and use of Federal funds for this Federally assisted project. Also, the Applicant gives assurance and certifies with respect to and as a condition for the grant that:

- 1. It possesses legal authority to apply for the grant, and to finance and construct the proposed facilities; that a resolution, motion or similar action has been duly adopted or passed as an official act of the applicant's governing body, authorizing the filing of the application, including all understandings and assurances contained therein, and directing and authorizing the person identified as the official representative of the applicant to act in connection with the application and to provide such additional information as may be required.
- 2. It will comply with the provisions of: Executive Order 11988, relating to Floodplain Management and Executive Order 11990, relating to Protection of Wetlands.
- 3. It will have sufficient funds available to meet the non-Federal share of the cost for construction projects. Sufficient funds will be available when construction is completed to assure effective operation and maintenance of the facility for the purpose constructed.
- 4. It will not enter into a construction contract(s) for the project or undertake other activities until the conditions of the grant program(s) have been met.
- 5. It will provide and maintain competent and adequate architectural engineering supervision and inspection at the construction site to insure that the completed work conforms with the approved plans and specifications; that it will furnish progress reports and such other information as the Federal grantor agency may need.
- 6. It will operate and maintain the facility in accordance with the minimum standards as may be required or prescribed by the applicable Federal, State and local agencies for the maintenance and operation of such facilities.
- 7. It will give the grantor agency and the Comptroller General, through any authorized representative, access to and the right to examine all records, books, papers, or documents related to the grant.
- 8. It will require the facility to be designed to comply with the "American Standard Specifications for Making Buildings and Facilities Accessible to, and Usable by the Physically Handicapped," Number A117.1-1961, as modified (41 CFR 101-17-7031). The applicant will be responsible for conducting inspections to insure compliance with these specifications by the contractor.
- 9. It will cause work on the project to be commenced within a reasonable time after receipt of notification from the approving Federal agency that funds have been approved and will see that work on the project will be prosecuted to completion with reasonable diligence.
- 10. It will not dispose of or encumber its title or other interests in the site and facilities during the period of Federal interest or while the Government holds bonds, whichever is the longer.
- 11. It agrees to comply with Section 311, P.L. 93-288 and with Title VI of the Civil Rights Act of 1964 (P.L. 83-352) and in accordance with Title VI of the Act, no person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which the applicant receives Federal financial assistance and will immediately take any measures necessary to effectuate this agreement. If any real property or structure is provided or improved with the aid of Federal financial assistance extended to the Applicant, this assurance shall obligate the Applicant, or in the case of any transfer of such property, any transferee, for the period during which the real property or structure is used for a purpose for which the Federal financial assistance is extended or for another purpose involving the provision of similar services or benefits.
- 12. It will establish safeguards to prohibit employees from using their positions for a purpose that is or gives the appearance of being motivated by a desire for private gain for themselves or others, particularly those with whom they have family, business, or other ties.
- 13. It will comply with the requirements of Title II and Title III of the Uniform Relocation Assistance and Real Property Acquisitions Act of 1970 (P.L. 91-646) which provides for fair and equitable treatment of persons displaced as a result of Federal and Federally assisted programs.
- 14. It will comply with all requirements imposed by the Federal grantor agency concerning special requirements of law, program requirements, and other administrative requirements approved in accordance with OMB Circular A-102, P.L. 93-288 as amended, and applicable Federal Regulations.

- 15. It will comply with the provisions of the Hatch Act which limit the political activity of employees.
- 16. It will comply with the minimum wage and maximum hours provisions of the Federal Fair Labor Standards Act, as they apply to hospital and educational institution employees of State and local governments.
- 17. (To the best of his/her knowledge and belief) the disaster relief work described on each Federal Emergency Management Agency (FEMA) Project Application for which Federal Financial assistance is requested is eligible in accordance with the criteria contained in 44 Code of Federal Regulations, Part 206, and applicable FEMA Handbooks.
- 18. The emergency or disaster relief work therein described for which Federal Assistance is requested hereunder does not or will not duplicate benefits received for the same loss from another source.
- 19. It will (1) provide without cost to the United States all lands, easements and rights-of-way necessary for accomplishments of the approved work; (2) hold and save the United States free from damages due to the approved work or Federal funding.
- 20. - 21. It will comply with the flood insurance purchase requirements of Section 102(a) of the Flood Disaster Protection Act of 1973, Public Law 93-234, 87 Stat. 975, approved December 31, 1973. Section 102(a) requires, on and after March 2, 1975, the purchase of flood insurance in communities where such insurance is available as a condition for the receipt of any Federal financial assistance for construction or acquisition purposes for use in any area that has been identified by the Director, Federal Emergency Management Agency as an area having special flood hazards. The phrase "Federal financial assistance" includes any form of loan, grant, guaranty, insurance payment, rebate, subsidy, disaster assistance loan or grant, or any other form of direct or indirect Federal assistance.
- 22. It will comply with the insurance requirements of Section 314, PL 93-288, to obtain and maintain any other insurance as may be reasonable, adequate, and necessary to protect against further loss to any property which was replaced, restored, repaired, or constructed with this assistance.
- 23. It will defer funding of any projects involving flexible funding until FEMA makes a favorable environmental clearance, if this is required.
- 24. It will assist the Federal grantor agency in its compliance with Section 106 of the National Historic Preservation Act of 1966, as amended, (16 U.S.C. 470), Executive Order 11593, and the Archeological and Historic Preservation Act of 1966 (16 U.S.C. 469a-1 et seq.) by (a) consulting with the State Historic Preservation Officer on the conduct of investigations, as necessary, to identify properties listed in or eligible for inclusion in the National Register of Historic places that are subject to adverse effects (see 36 CFR Part 800.8) by the activity, and notifying the Federal grantor agency of the existence of any such properties, and by (b) complying with all requirements established by the Federal grantor agency to avoid or mitigate adverse effects upon such properties.
- 25. #### **Complaint History:**

On 10-18-2024, the Town of River Bend received an email from a citizen within the Lakemere Dr. community. The citizen expressed concern with the current speed limit and "several chronic offenders". The complainant alerted to a the speed limit being too high for the residential road and desired to "prevent loss of life or accidents".

### **Prior History:**

There have been limited crashes within this community due to the very narrow road. The crashes involved mailboxes.

There has not been any complaints of traffic violations reported in the past that could be located in RMS.



#### Geography and Demographics of Canebrake:

- The Lakemere community is made up of approximately 85 residential homes
- The posted speed limit is currently 25 M.P.H.
- Majority of residents in the Lakemere community are over the age of sixty (50)
- This is a very active community among neighbors interacting with each other by walking to various events they host each week within the community
- The residents can be found daily walking for exercise
- The residents can be found daily walking animals
- The Lakemere community does not have sidewalks
- There are no outlets to Lakemere
- There is only one (1) entry and exit to the community

#### What is a Speed Study:

A speed study is an analysis of the speeds at which vehicles are traveling on a particular road or section of road. This type of study is typically conducted by local or state transportation agencies in order to identify areas where speeding is a problem and to develop strategies for addressing the issue. Speed studies can be used to assess the effectiveness of speed limit enforcement, engineering solutions (such as speed bumps), and public education campaigns.

One of the traditional methods for conducting a speed study is to use a radar gun to measure the speeds or passing vehicles, but this requires the time of personnel.

Speed studies are important tools for transportation planners and engineers, as they can help identify areas where speeding is a problem and where safety improvements are needed.

#### **Speed Survey:**

A speed study was conducted the week of November 1 through November 7, 2024.

The results of the speed study shows that four (10) vehicles were between 26-30 miles per hour (MPH). These vehicles were recorded on the All-Traffic Solutions radar calming device.

During this speed study, there were 1987 vehicles that traveled East and West along Lakemere Drive.

The speed study results are attached to this report.

#### **Recommendations:**

After the speed study results were gathered, lengthy discussions with traffic specialists held, and on-scene observations of Lakemere Drive; the River Bend Police Department makes the following recommendations:

The recommendations made are the least intrusive to the community, easiest to enforce and can take place quickly without high cost to the town.

The first recommendation is to start with two (2) stop signs on Lakemere Drive and Lauren Court. Also place a stop sign on Lauren Court at Lakemere Drive. This will create a new three-way stop. This will force drivers to reduce speed and stop, which will reduce the speed of moving traffic.

The second recommendation would be to place 15 M.P.H. signs throughout Lakemere Drive to reduce the current speed limit from 25 M.P.H.

# Volume by Speed Lakemere, EB



## **Volume by Speed**








REGIONAL HAZARD MITIGATION PLAN 2025 UPDATE

# **Project Background**

The Pamlico Sound Regional Hazard Mitigation Plan aims to assess, reduce, and prepare for the impact of natural and man-made hazards in the region. The 2025 Plan Update involves the identification of vulnerabilities and prioritization of mitigation strategies to better prepare for, respond to, and recover from a hazardous event. Through collaboration and coordination, the Plan Update seeks to engage stakeholders, raise awareness, and facilitate measures to mitigate risk and build a safer, more resilient region for current and future generations.

## **Initial Mitigation Strategies**

In effort to gain public input, a Public Survey was developed as part of the planning process. Within the survey, participants were asked "What are some steps your local government could take to reduce the risk of future hazard damages in your neighborhood?"

These responses were reviewed to identify problem statements, common themes, and initial mitigation strategies. Initial mitigation strategies were then categorized into one (1) of the six (6) mitigation techniques summarized above.

# Review the initial mitigation strategies and consider:

- 1. Is this already in place?
- Has this been proposed in the previous plan (2020)?
- Should this be a new strategy in the 2025 update?

# **Mitigation Techniques Defined**

- Prevention Planning measures aimed at avoiding or reducing the risk of hazards before they occur (e.g. land-use planning, zoning regulations, building codes)
- 2. **Property Protection** –Actions taken to safeguard structures and properties from damage (e.g. retrofitting buildings, elevating structure, installing storm shutters)
- 3. **Natural Resource Management** Sustainable management and conservation of natural systems to reduce hazard impacts (e.g. wetland preservation, floodplain restoration, sustainable forestry)
- 4. **Structural Projects** Large-scale engineering projects designed to reduce hazard impacts (e.g. levees, dams, seawalls)
- 5. **Emergency Services** Activities and plans designed to prepare for, respond to, and recover from emergencies (e.g. early warning systems, evacuation plans, emergency shelters)
- 6. **Education and Awareness** Efforts to inform and educate the public and stakeholders about risks and mitigation strategies (e.g. public awareness campaigns, community workshops)
