TOWN MANAGER'S REPORT

The Town Council has passed the budget for the new fiscal year, which began on July 1st. The total operating budget for the Town for Fiscal Year 2025-26 is \$4,390,684. The Council discussed the proposed budget over the course of four budget workshops during April and May. A public hearing on the proposed budget, as is required by law, was conducted on June 12. As always, all of the budget workshop documents were available on the town's webpage, and they are still posted if you would like to look at them. In fact, several years of budget documents are available on our web page, as well as a handy 5-year budget comparison.

With the new budget, the town's tax rate will increase from 24¢ to 28¢. For the average homeowner, that will increase your tax bill by \$103 per year. There is also a new, annual \$10 per vehicle license fee which will be assessed on every registered vehicle in River Bend. You will see this fee when you receive your vehicle registration bill from the NC Division of Motor Vehicles. The rates for water and sewer service will remain unchanged. The average home in River Bend is valued at \$246,722 and the average utility customer uses 3,225 gallons of water/sewer per month. Therefore, the average resident will pay \$691 in town tax and \$960 in utility fees in FY25-26, which is \$4.52 per day. For \$4.52 per day, the average resident will receive potable water, wastewater treatment, 24/7 police protection, stormwater management, animal control, planning, zoning, code enforcement, parks, recreational events, street lights, street maintenance, leaf & limb removal, and a host of other services. Last year, the daily cost was \$4.24 per day. Our goal is to continue to deliver high quality services at a reasonable price to all who make River Bend their home. Many people spend more than \$4.52 per day on coffee alone. Hurricane season is here. If you have not seen it, please visit our webpage and review the "Hurricanes.... Are you ready?" bulletin.

REPORTING AFTER HOURS WATER-SEWER EMERGENCIES

- ◆ Dial Town Hall at 638-3870.
- ◆ Dial "9" and follow the directions to contact the on-call duty operator.
- ◆ Enter your phone number at the sound of the tone.
- ◆ The automated system will inform you that your page has been sent.
- ◆ Our utility operator will return your call.
- ◆ If you do not receive a call back within ten minutes, please notify the Police Department at 638-1108 (option 1). They will get in touch with the on-call utility system

The Public Works Department conducted herbicide spraying around the Town Hall area to control unwanted vegetation growth. In addition, similar spraying was performed in the town parks and along fence lines. This work reduces the need for extensive weed eating, improving efficiency and overall appearance. All chemicals were approved and applied according to label directions and safety guidelines. Also, several damaged or weathered street signs were replaced. This work enhances visibility and supports public safety.

Water Resources utilized our sewer Jetter to clean several sections of a sanitary sewer system. This work is part of our routine maintenance program and is necessary to meet permit requirements. Regular jetting helps keep down on odor complaints and helps prevent blockages and sanitary sewer overflows. Down at the Wastewater Treatment plant several air diffusers were pulled and cleaned. These diffusers are essential for mixing and aerating the wastewater, creating ideal conditions for beneficial microorganisms to break down organic material and maintain system performance.

If you have any questions concerning the Water Resources/Public Works Department, please call us at 252-638-3540, Monday-Friday, 8am-4pm. After-hours water and sewer emergencies can be reported by dialing the Town Hall at 252-638-3870. You will be instructed to dial "9" and follow the directions to contact the on-call duty operator. You will then be asked to enter your phone number at the sound of the tone. After entering your phone number, the automated system will inform you that your page has been sent. Please, be patient and our utility systems operator will return your call. If you do not receive a call back within ten minutes, please notify the Police Department at 252-638-1108 (option 1), and they will get in contact with the on-call utility systems operator.

Golf Cart Registration

Town ordinances allow for residents to drive their properly equipped golf carts on River Bend streets provided that they are inspected by and registered with our Police Department. If you plan to drive your golf cart on the roadways, you must display the current year registration decal. Decals for 2025 are available now. Inspection and registration are required annually.
