TOWN MANAGER'S REPORT

The Atlantic Hurricane season runs from June 1 through November 30 each year. Historically, fall is the most active part of hurricane season for our region. August and September are usually the busiest months for hurricanes along North Carolina's coast. However, a hurricane could develop outside of the official hurricane season. The National Oce-

anic and Atmospheric Administration (NOAA) is predicting an above-normal Atlantic hurricane season for 2024. In fact, this year's forecast, with 25 named storms, is the most ever in a NOAA preseason forecast. NOAA director Rick Spinrad said the Atlantic Hurricane season is shaping up to be extraordinary. Our proximity to the Atlantic coast, combined with the low elevation above sea level for large parts of our town, makes River Bend vulnerable to impacts from hurricanes. A tropical system does not need to develop into a hurricane to cause damage in River Bend, particularly in the flood zone. Click here to view our flood zone maps, which were developed by FEMA. Enter your address (street, city, state, zip) then click on GO for the map. For this site, enter New Bern as your city. Based on our history and geography, if you live in River Bend, you may want to consider purchasing flood insurance. You can obtain a policy from a local agent, through the National Flood Insurance Program (NFIP). The Town of River Bend is a participant in the Community Rating System (CRS) of the NFIP. In short, that means that the town maintains records and files on flood zone properties, has and enforces a local flood damage prevention ordinance and meets other annual minimum requirements to be a CRS participant. Our CRS status means that River Bend residents who live in a special flood hazard area (SFHA) are eligible for a 10% discount on annual flood insurance policy premiums. Those living in other areas could be eligible for a 5% discount. Typically, regular homeowner's insurance policies do not cover damages from rising waters

(flooding). If you are uncertain about your insurance coverage, you should contact your agent now. Do not wait until after the storm to learn that you are not covered. Most insurance companies require flood insurance to be purchased at least 30 days prior to a named storm that impacts a customer. That means that you cannot buy coverage at the last minute when a storm is already headed in our direction.

Although it has been almost 6 years ago, Hurricane Florence is still in the memory of many River Bend residents. Our records show that 503 homes in River Bend were flooded by Hurricane Florence. According to data from the NFIP, just before Hurricane Florence made landfall on September 14, 2018, there were 443 flood insurance policies in effect in River Bend. That means there were at least 60 flooded homes that did not have flood insurance. As of this week, there are 415 flood insurance policies in effect in River Bend. At this time last year, there were 554 in effect.

Now, and throughout the summer, is a good time for you to assess your property and see if you are ready for a hurricane or even a smaller magnitude tropical storm. Public Works has undertaken several key initiatives to enhance the community's infrastructure and safety. Activities included the excavation of a ditch line to bolster stormwater flow, alongside the clearing of discharge ends of storm water pipes for improved drainage efficiency. Additionally, trimming low hanging limbs along town roads

not only enhanced visibility but also mitigated potential damage to larger vehicles. In a bid to ensure recreational safety, mulch was added to the swing set area at Ritter Field with plans to add more.

Water Resources repaired several sewer lateral cleanouts. Residents are urged to report any uncapped cleanouts in their yards, as these pose a risk for inflow and infiltration. Noteworthy is the recent inspection conducted by the NC Department of Environmental Quality on our wastewater plant and backwash sites, which yielded no violations, affirming our commitment to regulatory compliance and environmental stewardship.

system will inform you that your page has been sent. Please, be patient
and our utility systems operator will return your call. If you do not
receive a call back within ten minutes, please notify the Police
Department at 252-638-1108, and they will get in contact with the oncall utility systems operator.

Golf Cart Registration

Town ordinances allow for residents to drive their properly equipped golf carts on River Bend streets provided that they are inspected by and registered with our Police Department. If you plan to drive your golf cart on the roadways, you must display the current year registration decal. Decals for 2024 are available now.

Inspection and registration are required annually. The registration fee for each golf cart is \$10.

Registration is Required for all Dogs and Cats

River Bend Animal Registrations for 2024 were due by March 31, 2024. All River Bend dogs and cats must be registered annually.

Office hours are Monday-Friday, 8 AM-4 PM.

Owners must present proof of rabies vaccination at the time of registration. Click HERE for more information.

Registration is \$10.00 per pet.

The Town of River Bend is now offering residents the opportunity to link a digital photo of their registered pets to our Animal Registration database. When you register your pet this year, you may submit a photo by e-mail, or staff can scan a photo for you if you prefer. This photo database will help reunite lost pets with their owners more quickly in the event a pet becomes lost.

The service is voluntary and free of charge.

DOG PARK AT RIVER BEND



River Bend dogs have their own exercise area where they can play with other canines. Situated between the Town Park and Ritter Field, the dog park gives dogs a chance to run while their owners socialize.

The park is open from sunrise to sunset for dogs with proof of current vaccinations. Separate exercise areas accommodate large and small dogs.
