TOWN MANAGER'S
REPORT

I am pleased to make an historic announcement. The Town of River Bend was recently awarded the largest grant in the town's history. In my opinion, it is also the most important project in the town's history. The \$9,393,000 grant will fund the construction of a new water treatment plant.

October will bring my 9th anniversary as Town Manager in River Bend. One issue that has persisted during my tenure, and for many years prior to my

arrival, is the intermittent appearance of red-brown colored water and consistent hard water. Both of those aesthetic issues are attributable to naturally occurring calcium, iron and manganese, which are found in water from the Castle Hayne Aquifer. The aquifer covers a 12,500 square mile area in eastern North Carolina. Basically, the boundary of the aquifer within North Carolina covers the area along Highway 17 and east from Wilmington to Virginia.

Our town has 3 wells that pump water from the aquifer, then it is treated, pumped to our elevated storage tanks and distributed to our customers. Our treatment system for all 3 wells is old and does not offer the treatment capability to soften water or remove the source of the discoloration. In 2020, we had an engineer study our water supply and treatment system. That report is on our web page and can be found here.

We are aware of the issues and concerns and the need to make improvements to our water treatment system. We are also aware that the needed improvements are very costly. Our water system is operated as an Enterprise Fund. That means that all costs associated with operating the water system are paid for with revenues generated by the water system only. Revenue from taxes or sewer fees do not support the water system. Likewise, water revenue is not used to support the sewer system or general fund activities. All 3 funds are operated separately and support themselves. Funding this project with water revenue alone would have resulted in a sizeable rate increase for water customers.

When the U.S. Federal government passed the American Rescue Plan Act, it provided funds to all states that could be used for many activities. North Carolina earmarked a tremendous amount of its funding to offer grants for improvements to municipally-owned water and sewer systems. We decided to submit a grant application for our water system needs. The grant was a competitive-based process with points being awarded to applications that met certain criteria. Our application scored very well. In fact, we scored in the Top 10 of all applicants statewide,

during both rounds of funding review. However, since we were recently awarded a \$9,108,500 grant from the same grant funds for a sewer project, a maximum funding limit prevented our water application from being approved.

Following that decision, we decided to seek funding through the State's budget process. Again, we requested \$9,393,000 in funding. We enlisted the help of our local legislators in the NC Senate and House of Representatives to help secure the funding. Senator Jim Perry and Representative Steve Tyson recognized the importance of our project and were made aware of its high-scoring performance during the official grant review process. With the recent approval of the State's budget, the Town of River Bend was approved to receive a \$9,393,000 grant for the construction of a new water treatment plant. All of our existing treatment facilities will be abandoned and the new facility will treat all of the water. The treatment level will be enhanced to address the red-brown water issue and the new facility will also provide water softening to address the hardness issue. Now that funding is in place, there is much more design and engineering work that must be done. We also have not secured the land for the new facility. That process is underway. It may be up to 1 year before we are ready to accept bids on this project. After that, it may be up to 2 years before construction is completed. We will try to complete this project as soon as possible. We look forward to putting the new plant on-line.

Public Works repaired one critical issue with a storm drain. A sink hole had formed over the top of the damaged pipe. There was a hole in one of the joints that required immediate attention. We have successfully repaired the storm drain to prevent any further issues, and to ensure efficient drainage during inclement weather. We have continued to trim limbs along the roadways to prevent hazards and obstructions. There are still many areas on our list.

With the recent tropical system that flooded the roadways in the Channel Run area, we took on some inflow and infiltration into the sewer system. We have located a couple of sources for this. One had a missing cleanout cap, and the other had a manhole liner missing. Both have been repaired by our staff. In the upcoming weeks, we are planning to conduct a smoke test in our sewer system with focusing on this area first. By identifying potential leaks and sources of water, we aim to improve the efficiency of our system.

Golf Cart Registration

Town ordinances allow for residents to drive their properly equipped golf carts on River Bend streets provided that they are inspected by and registered with our Police Department. If you plan to drive your golf cart on the roadways, you must display the current year registration decal. Decals for 2023 are available now.

Inspection and registration are required annually. The registration fee for each golf cart is \$10.
