BEWARE AS YOU DIG IN YOUR YARD

This article is written to alert all River Bend residents that modern utilities that serve us every day are buried in our street rights-of-way. Service to your residence runs under your lawn to the point where the individual utility service enters the home. The utilities include electric (generally buried throughout Town), natural gas (soon the entire Town will have this buried service), water (service throughout Town), sewer (service in approximately 50% of Town) and cable

(Suddenlink currently is installing a conduit system throughout Town and will then provide fiber-optic service through that conduit system). Telephone service lines also are buried.

All of these utility systems are vulnerable to damage by close excavation or drilling. Furthermore, electric and gas lines can be very dangerous if severed during excavation or driving of stakes.

When planning an excavation for any purpose, residents need to request marking of location of utilities so damage can be avoided.

By dialing 811, you can find out where utility owned lines are located on your property. Following your call, NC811 will notify their member utility companies of your excavation needs and they will locate their buried utility lines at no charge to you.

POST HURRICANE FLORENCE RECOVERY

We are now eight months past the devastating effects of Hurricane Florence. Many homeowners have experienced significant damage to homes and loss of furnishings. The recovery has been slow and frustrating since professional contracting

assistance remains in short supply. The Town will return to "normal," but at a date still unknown. I hope that residents who are new to the Town and the area will have attended the June 1st CERT Severe Weather Safety Fair. The CERT volunteers work hard to inform residents of the dangers that will be encountered

during hurricanes or other storms that make landfall in our area of the North Carolina Coast. Hurricane Florence may have been categorized as a 500-year storm, but there is no guarantee that a Florence twin will not make landfall in a much shorter time frame.

We seldom consider the total regional extent of hurricane damage. In the Hurricane Florence aftermath the Coastal Environmental Partnership landfill (Tuscarora) was the location where all the debris generated by hurricane destruction in Craven,

available for this construction without borrowing. Funds are available because of visionary planning of the Board when setting the rate structure for operations.



TOWN MANAGER'S REPORT BY TOWN MANAGER DELANE JACKSON

For several years the Town Council has been working on its Building Utilization Strategy (BUS). During that time, the Council considered multiple plans and multiple sites. After conducting nine BUS meetings, receiving considerable public comment, having years of discussions, including recommendations and reports from engineers and architects, in March the Council unanimously decided to move forward on a 3,900 square foot, multi-purpose building plan and on

a designated building site. The proposed new building will be the home of the River Bend Police Department. The proposed building site is where the basketball court is currently located in Town Commons, near the Red Caboose. The plan is to move the basketball court to the site of the former barn, on Wildwood Drive.

The Town Council awarded a contract to The Walker Architectural Group of New Bern to produce a set of plans and specifications for the building and a site plan. They are currently working on the plan. Once that has been completed, the Town will solicit bids on the construction project. We hope to have that

process complete and ready for Council consideration by mid-July. Currently, the estimated cost of the building is \$764,350. Once bids are received, the Town will know the actual costs of construction. At that time, the Council will be equipped to make a final decision on whether or not to proceed.

The BUS plan also includes changes to the current Town Hall. The Council previously solicited bids for a new addition to Town Hall. The bids came in higher than expected, and that project was tabled so that we could focus on the new building. During the bidding process for the multi-purpose building, we will also receive bids for the Town

Hall modifications. Again, based on the bids received for the Town Hall, the Council will be equipped to decide whether or not to proceed with that addition as planned. The plan for Town Hall includes converting the existing bathrooms into office space and building new ADA-compliant bathrooms on the front of the building, along with some other minor modifications.

During Hurricane Florence, the building that housed the Public Works and the Police Departments was flooded. The \$45,000 contract to repair that building and another that was flooded, was awarded to Tyson Construction and Restoration. That project is complete, and we are in the process of moving back into that space. The plan is for that building to be used solely by Public Works. The Police Department remains in a temporary location on Highway 17 as we await a final decision on BUS.



WRD/PW APRIL REPORT BY BRANDON MILLS DIRECTOR OF PUBLIC WORKS

In April, Public Works added gravel to rutted areas along some of the Town's roadways. The purpose of this is to protect the road edge from crumbling and breaking off. We also made a few minor asphalt repairs. Public Works also replaced the dog park drinking water fountain valve. It is great to see our nice dog park being used as it is. There are always citizens and their canine companions enjoying it. We also pressure washed the kiddy playground by Town Hall.

Occasionally we have to pressure wash it to remove grime/dust.

Water Resources finished flushing the Town's water distribution system. The whole process went smoothly and all hydrants were checked for proper function. No hydrants were reported as not working properly. An alarm system control board went bad on one of the Town's collection system lift stations. A member of our team replaced the board. We also had to pull a lift station pump due to a bad seal. We replaced the seal the same day, and reinstalled the pump back into service.

After entering your phone number, the automated system will inform you that your page has been sent. Please be patient, and our utility systems operator will return your call. If you do not receive a call back within ten minutes, please notify the Police Department at 638-1108, and they will get in contact with the on-call utility systems operator.

Golf Cart Registration

Town ordinances allow for residents to drive their properly equipped golf carts on River Bend streets provided that they are inspected by and registered with our Police Department. If you plan to drive your golf cart on the roadways, you must display the 2018 registration decal.

Inspection and registration are required annually. The registration fee for each golf cart is \$10.

Registration is Required for all Dogs and Cats

All River Bend dogs and cats must be registered annually.

Office hours are Monday through Friday, 8:00 a.m. through 4:00 p.m. Registration is \$10.00 per pet.

Owners must present proof of rabies vaccination at the time of registration.



Pet I. D. Photos Now Available

The Town of River Bend is now offering residents the opportunity to link a digital photo of their registered pets to our Animal Registration database. When you register your pet this year, you may submit a photo by e-mail, or staff can scan a photo for you if you prefer. This photo database will help reunite lost pets with their owners more quickly in the event a pet becomes lost.

The service is voluntary and free of charge.

DOG PARK AT RIVER BEND



River Bend dogs have their own exercise area where they can play with other canines. Situated between the Town Park and Ritter Field, the dog park gives dogs a chance to run while their owners socialize.

The park is open from sunrise to sunset for dogs with proof of current vaccinations. Separate exercise areas accommodate large and small dogs.
