rushing crowds, the flow of street cars, wagons, buggies, hacks and now and then an automobile". Ten years later a few new skyscrapers dotted the city's skyline, but the streets were still crowded and busy and Memphis remained very much the same, with one exception: the automobile occasionally encountered in 1910 had become by 1920 one of the most pervasive features of urban life."

In our year 2016 in Memphis the wagons, buggies and hacks would draw much more attention than did the automobile in 1910. Change in transportation happened quite quickly and the change in vehicle design continues to this day.

In January, the Public Works Department repaired two storm water catch basins. One side of the catch basin had collapsed and had to be repaired. We formed it up and poured a new sidewall. The other catch basin needed minor joint repair. Public Works also sprayed the Town's walking trail with herbicide to kill the unwanted vegetation growing up through the rock on the path. This not only keeps the path more defined, but also enhances the general appearance

around the park. All the walking path exercise equipment, signs, and railings were pressure washed to remove algae growth. This also enhances the appearance of the park.

Water Resources had two lift station pumps that had to be pulled and unclogged. The pumps had become clogged with cloth like material around the impellers of both pumps. When this happens the pumps and impellers can no longer spin freely. This causes the pump to draw excessive amperage and to overload and trip the motor. Our staff quickly repaired these pumps. We also repaired a couple of aeration basin diffusers at the Wastewater Treatment Facility. As a reminder, our Wastewater Treatment Facility is an aerobic process. Microorganisms that treat our incoming wastewater need oxygen to live and reproduce. Without proper oxygen levels the process would not work.

If you have any questions concerning the Water Resources/Public Works Department, please call us at 638-3540, Monday-Friday, 8am-4pm. After hour's water and sewer, emergencies can be reported by dialing the Town Hall at 638-3870. You will be instructed to the dial "9" and follow the directions to contact the on call duty operator. You will then be asked to enter your phone number at the sound of the tone. After entering your phone number, the automated system will will inform you that your page has been sent. Please, be patient and our utility systems operator will return your call. If you do not receive a call back within ten minutes, please notify the Police Department at 638-1108, and they will get in contact with the on-call utility systems operator.

Golf Cart Registration

Town ordinances allow for residents to drive their properly equipped golf carts on River Bend streets provided that they are inspected by and registered with our Police Department. If you plan to drive your golf cart on the roadways, you must display the 2021 registration decal. Decals for 2021 were available beginning December 2, 2020.

Inspection and registration are required annually. The registration fee for each golf cart is \$10.

Registration is Required for all Dogs and Cats

River Bend Animal Registrations for 2021 are due by March 31, 2021. All River Bend dogs and cats must be registered annually. Registration is \$10 per pet, and may be placed in our payment drop box while Town Hall is closed to the public.

Owners must present proof of rabies vaccination at the time of registration. Please include documentation with your payment.
